



Justice Judith Prakash

Senior Judge

Supreme Court of Singapore

(Former Justice of the Court of Appeal)

Justice Judith Prakash was appointed Justice of Appeal on 1 August 2016 (later re-designated Justice of the Court of Appeal), the first woman to be appointed a permanent judge of the Singapore Court of Appeal. She retired on 18 December 2023 and was appointed Senior Judge on 2 January 2024.

Justice Prakash graduated from the University of Singapore in 1974 and was admitted as an advocate and solicitor in Singapore the following year. Thereafter she was in private practice until 1992. Starting as a shipping lawyer, she subsequently practiced commercial law in the areas of banking and finance and company law. She joined the Supreme Court as Judicial Commissioner in 1992 and became a High Court Judge in 1995.

Until 2022, Justice Prakash was the Lead Judge for arbitration matters. She sat on many cases involving arbitration issues, both at first instance and on appeal, and was one of the Supreme Court specialist arbitration judges. Other areas in which she had a special interest include family law and trusts, and in the commercial area, banking, finance, shipping and insurance law. She has served more than two decades in the Supreme Court and many of her judgments, particularly on arbitration and commercial law, have been influential both domestically and internationally.

Justice Prakash sits on the Boards of Trustees of the Singapore Indian Development Association and The Eurasian Association.



Mr Tan Chong Meng

Mr Tan Chong Meng was the Group CEO of PSA International (PSA) until his retirement in March 2024. He joined PSA on 1 October 2011, bringing a wealth of experience in managing the complexity, diversity and breadth of a global business. PSA is a leading global port group and trusted partner to cargo stakeholders around the world.

Mr Tan currently serves as the Chairman of JTC and is Deputy Chairman on the board of the National University Health System (NUHS). In January 2022, he assumed the role of Governor Chair for The World Economic Forum's Supply Chain & Transport Industry Community. He also served as Co-Chairman of the Emerging Stronger Task Force in 2020-2021, a committee set up by the Singapore government to guide the nation's economic recovery from the COVID-19 pandemic. He was previously a Board Member of IE Singapore.

In May 2023, Mr Tan received two awards: the honour of the Officer of the Order of the Star of Italy — one of the country's highest civil honours recognising individuals who made outstanding contributions to promote friendly relations and cooperation between Italy and other countries; and the Singapore's National Trades Union Congress Medal of Commendation (Gold) award for his continuous and significant contributions towards promoting and supporting Labour Movement initiatives. He was also awarded the Meritorious Service Medal in December 2022 for his various roles in the nation's fight against COVID19.

Before joining PSA, Mr Tan was Executive Vice President, Global Commercial, Shell Downstream of the Royal Dutch Shell Group. A global leader with more than 20 years of experience in Shell, Mr Tan worked in USA, Europe, China and Singapore, holding various senior leadership positions that spanned management, sales, marketing, trading, refinery operations, customer service and merger & acquisitions. Mr Tan had also worked with the Ministry of National Development, Singapore in various positions for five years.

Mr Tan received a graduate degree in Industrial Engineering and an undergraduate degree in Mechanical Engineering from National University of Singapore.



Mr Ravi Menon

Former Managing Director
Monetary Authority of Singapore

Mr Ravi Menon was the longest-serving Managing Director of the Monetary Authority of Singapore (2011-23). Under his leadership, MAS implemented effective monetary and macroprudential policies, reformed the financial regulatory framework, and developed Singapore as a vibrant green finance centre and a global FinTech hub. As Permanent Secretary at the Ministry of Trade & Industry (2007-11), Mr Menon helped support the economy during the global financial crisis. As Deputy Secretary at the Ministry of Finance (2003-07), he helped to formulate fiscal policies.

Mr Menon has played a leading role in international finance. He was Chairman of the Network of Central Banks and Supervisors for Greening the Financial System and the Financial Stability Board Standing Committee on Standards Implementation.

Mr Menon has served on several boards in the public, private, and people sectors, including as Chairman of the Institute of Banking and Finance and the Singapore Co-operation Enterprise; Deputy Chairman of the Central Provident Fund Board; and Board Director of the Housing and Development Board and DBS Bank.

Mr Menon has received several awards, including the Meritorious Service Medal and Public Administration (Gold) Medal from the Singapore Government, the Distinguished Leadership and Service Award from the Institute of International Finance, and Central Bank Governor of the Year (Asia-Pacific) from The Banker.

Mr Menon is currently Chairman of the Glasgow Financial Alliance for Net Zero (GFANZ) Asia-Pacific Advisory Board and a member of the GFANZ Principals Group. He is also a Trustee of the Singapore Indian Development Association.

Mr Menon holds a Master's in Public Administration from Harvard University and a Bachelor of Social Science (Honours) in Economics from the National University of Singapore.
