By purchasing certified raw materials, we know that our products have been produced under conditions that match our guidelines, from the beginning to the end of the chain.

Sustainable materials

Wherever possible, HEMA strives to use sustainable raw materials. This applies to raw materials such as wood, coffee, tea, cocoa, as well as cotton. In collaboration with business partners, other environmentally friendly raw materials and materials are also sought. Advances in the field of possible harmful substances may mean that a substance that is currently considered safe may be considered a (health) risk in the future. HEMA makes every effort to only use raw materials that are safe for people and the environment. In the event that well-founded suspicion arises regarding the safety of certain substances, a safe alternative will be sought in cooperation with our business partners.

When sourcing sustainable raw materials, HEMA demands the adoption of credible third-party certification programs or standards. In 2022, HEMA was certified by Control Union (CU) to carry GOTS and Textile Exchange labels. These labels, and other accepted certifications and standards, are included in the table below.
